#### **About ISD**

ISD is a global counter-extremism organisation dedicated to powering solutions to extremism and polarisation. #### About the Strong Cities Network (SCN)

Launched at the United Nations in September 2015, the Strong Cities Network (SCN) is the first ever global network of mayors, municipal-level policy makers and practitioners united in building social cohesion and community resilience to counter violent extremism in all its forms.

Led by ISD and comprised of more than 120 cities, the SCN builds collaboration between mayors, political actors and frontline teams to tackle polarisation, hate and violence in local communities in every major global region. The network catalyses, inspires and multiplies community-centric approaches and action to prevent and counter violent extremism (P/CVE) through peer learning and expert training. It operates with a set of fundamental principles, agreed by all members, that protect and promote human rights and civil liberties in all aspects of its work to prevent violent extremism.

#### **Project context**

ISD's SCN team are delivering a complex and fast-paced programme of work funded by the United States Department of State through to September 2020, focused on building the capacity of local government to prevent and respond to radicalisation and recruitment. This grant focuses on four key global regions: Central Asia; South Asia; Sub-Saharan Africa; and the Western Balkans, with different pilot models, associated deliverables, and expected outcomes in each region.

A key area relevant to this role will be our work in the Western Balkans. The SCN will create, train and support a multi-stakeholder 'Local Prevention Network' of key community actors to design a municipal-led policy on P/CVE and coordinate a programme of activities in the community. Stakeholders are likely to include the municipality, educators, youth workers, religious leaders etc., and the network's policy framework and activities will need to be coordinated and integrated with existing programmes and national policy. Kumanovo, North Macedonia and is based on existing work and established practice models the SCN has implemented in Jordan and Lebanon since 2016. It will also see the identification of up to three 'co-pilot' cities spanning Albania, Kosovo and North Macedonia with which learnings developed in Kumanovo will be shared through regional city exchanges and a regional workshop.

In South Asia and Sub-Saharan Africa, the SCN will also identify a pilot grouping of 3-4 cities per region to develop municipal competency on a specific thematic area of P/CVE. This will be delivered through a programme of on-the-ground consultations with mayors, local policymakers and practitioners, regional city exchanges and workshops, and a series of small partnership grants to civil society organisations.

In Central Asia, a new region for SCN engagement, we aim to recruit member cities, assess the current status of local government needs and capabilities on P/CVE, deliver training and sensitisation to policymakers and practitioners, and run an initial regional exchange to disseminate good practice.

Sustained engagement, improvements in knowledge and skills, practical changes to either local policy architecture or programmes/activities, and coordination with national government P/CVE priorities are key to determining the success of this project.

#### Scope of work

ISD seeks to engage a consultant to work with the ISD and SCN team on developing our monitoring and evaluation capabilities in support of our activities funded by the U.S. Department of State. The consultant will review existing M&E frameworks, advise on indicator and methodological improvements, and support the evaluation of key deliverable under the grant. The consultant will also be expected to travel to North Macedonia with the project team to undertake a situational review and develop a baseline assessment for the creation of a multi-stakeholder Local Prevention Network in Kumanovo municipality. The consultant will also support the design of surveys and focus groups to assess community and stakeholder attitudes and capabilities vis-à-vis community-based P/CVE initiatives. They will also support the team's development of data collection tools and indicators across the grant, including a small grants programme for civil society organisations, helping us transform activity-focused measures into outcomes-focused evaluation.

The consultant will report into the SCN Senior Manager and will work closely alongside our full-time SCN Data & Monitoring Coordinator as well as our Balkans Manager and the wider SCN and ISD team, with the aim of informing and supporting the development of wider institutional M&E practices.

The consultant will be required to work directly with the HQ-based team in London, through a mix of in-person and remote meetings. At least two field visits to North Macedonia will also be required.

#### Timing

It is anticipated that the consultant will be able to produce all of the deliverables outlined below within no more than 60 days' work over the period July 2019 to September 2020.

We anticipate this to be split into approximately 35 days' work in 2019 and 25 days' work in 2020, subject to review of technical and commercial proposals and discussion with the preferred consultant.

Our preferred start date is mid-July 2019 in order for the consultant to visit North Macedonia 15-19 July 2019, depending on availability.

# **Deliverables**

- 1. Lead a situation analysis in Kumanovo, North Macedonia which assesses current municipal-level P/CVE capabilities and supports the identification of indicators for the SCN Local Prevention Network, to be compiled in a written report.
- 2. Design and deliver a training programme for members of the Kumanovo Local Prevention Network on M&E approaches relevant to community-based P/CVE deliveries, including a short written 'Good Practice in M&E for local P/CVE initiatives" guide serving both the Local Prevention Network members as well as civil society organisations delivering local P/CVE activities
- 3. Undertake a thorough review of existing project and programme M&E frameworks and logic models, developing them to reflect best practice in international capacitybuilding and security/peacebuilding fields. This should include an updated log frame and theory of change relevant to both this grant and wider programme of work delivered by the SCN.
- 4. Review and revise overall SCN approaches to measuring By April 2020 engagement of and impact in its member cities, based on best practice for policymaker networks and tied to our central goal of improving the capacity of mayors, local policymakers and a diversity of local frontline practitioners to develop, coordinate and deliver effect P/CVE programmes.
- 5. Support an in-country review of outcomes delivered and By August 2020 changes achieved by the Kumanovo Local Prevention Network at the end of the project, through a written report.
- 6. Providing wider support and expert input to the project team To be determined in and wider ISD team on additional tasks to be determined. coordination with the SCN
